



Categories of members and membership fees

****Annual fee:**

The general assembly of members shall have the authority to determine an annual fee; conditions of payment thereto shall be determined by the board.

Corporate members:

Shall be a corporate member of the Corporation any business enterprise, government or national/international NGO who abides by the objectives and the activities of the Corporation, who pays its/his annual fee and to whom the board, upon request, grants the status of corporate member.

Corporate members shall have the right to participate in all activities of the Corporation and to receive notices of meetings of members, to attend such meetings and to vote at such; they are eligible as officers of the Corporation.

Corporate members may, upon providing verbal or written notice to the secretary of the Corporation, be replaced at the time of a meeting by a third party who shall speak on their behalf.

A third party who shall benefit from such status as representative-designate of a corporate member shall be automatically disqualified as corporate member when:

- a) the corporate member he/she represents dismisses him/or her from that function; or
- b) the corporate member he/she represents has withdrawn or has been dismissed as a member.

For the 2016-2017 season:

Cost: Annual fee of 500 \$

Community members

Shall be a community member of the Corporation any regional/local corporation, association, community or legal entity that shall abide by the objectives and the activities of the Corporation, that pays its annual fee and to whom the board, upon request, grants the status of community member.

Community members shall have the right to participate in all activities of the Corporation and to receive notices of meetings of members, to attend such meetings and to vote at such; they are eligible as officers of the Corporation.

Community members may, upon providing verbal or written notice to the secretary of the Corporation, be replaced at the time of a meeting by a third party who shall speak on their behalf.

A third party who shall benefit from such status as representative-designate of a community member shall be automatically disqualified as community member when:

- a) the community member he/she represents dismisses him/or her from that function; or
- b) the community member he/she represents has withdrawn or has been dismissed as a member.

For the 2016-2017 season:

Cost : Annual fee of 200\$

Support members :

Shall be a support member any person wishing to foster the activities of the Corporation providing they pay an annual fee.

Support members may not participate in the activities of the Corporation nor may they attend the meetings of its members. Hence, they are not eligible as officers of the Corporation; however, they may, from time to time, be made aware of the activities of the Corporation.

For the 2016-2017 season:

Cost : Annual fee of 50 \$

Student members :

Shall be a student member any student wishing to foster the activities of the Corporation providing they pay an annual fee.

Student members may not participate in the activities of the Corporation nor may they attend the meetings of its members. Hence, they are not eligible as officers of the Corporation; however, they may, from time to time, be made aware of the activities of the Corporation.

For the 2016-2017 season:

Cost : Annual fee of 20 \$

Honorary members :

The Corporation may grant the status of honorary member in specific circumstances largely intended to reward persons who have an overarching role in furthering the goals and objectives of the Corporation.

Honorary members may participate in the activities of the Corporation and attend the meetings of its members. Hence, they are eligible as officers of the Corporation.

For the 2016-2017 season:

Cost : 0 \$
